2. Hazards Identification

Emergency overview: DANGER. Flammable liquid and vapor. Vapors are heavier than air. Vapors may travel across the ground and reach remote ignition sources causing a flashback fire danger. Electrostatic charges may be generated during pumping. Electrostatic discharge may cause fire.

SIGNS AND SYMPTOMS OF EXPOSURE (SKIN, EYE CONTACT; INHALATION; INGESTION)

EYE CONTACT: Irritating to eyes causes redness and tearing.

INHALATION: Vapor may cause drowsiness and dizziness

INGESTION: Causes nausea, vomiting and gastrointestinal upset.

SKIN CONTACT: Repeated exposure may cause skin dryness or cracking.

4. First Aid Measures

EYES: Immediately flush eyes with a direct stream of water for at least 15 minutes. Hold eyelids apart to ensure complete irrigation of all eye and lid tissues. Get medical attention.

INGESTION: If swallowed, DO NOT induce vomiting. If victim is fully conscious, give large quantities of water to drink. Never give anything by mouth to an unconscious person. Get medical attention immediately.

SKIN CONTACT: Immediately flush skin with plenty of clean running water. Get medical attention if irritation persists.

INHALATION: Remove to fresh air. If breathing is difficult, oxygen should be administered by qualified personnel.

5. Fire Fighting Measures

FIRE FIGHTING METHOD: DO NOT direct a solid stream of water or foam into hot burning pools of liquid, since this may cause frothing and increase fire intensity.

EXTINGUISHING MEDIA: Alcohol-resistant foam, water spray or fog. Dry chemical powder, carbon dioxide may be used for small fires only.

UNUSUAL FIRE OR EXPLOSIVE HAZARD: None known.

6. Accidental Release Measures

PERSONAL PRECAUTIONS: Isolate area. Keep unnecessary personnel away.

ENVIRONMENTAL PRECAUTIONS: Keep out of sewers, storm drains, and waterways.

CLEAN-UP PROCEDURES: Ventilate area or leak or spill. Remove all sources of ignition. Contain spill with inert material such as vermiculite, dry sand, earth, then transfer to sealable containers for disposal. Flush contaminated areas with water.

HYGIENIC PRCTICES IN HANDLING AND STORING: Wash thoroughly after handling. Avoid body contact.
