2. Hazards Identification

Emergency overview: WARNING. Can cause irritation to skin, eyes, and throat.

SIGNS AND SYMPTOMS OF EXPOSURE (SKIN, EYE CONTACT; INHALATION; INGESTION)

EYE CONTACT : Exposure to dust will cause irritation, redness and tearing.

INHALATION : Inhalation of dust will cause coughing and sneezing due to severe upper respiratory tract irritation.

INGESTION : Causes irritation of mouth, throat, and gastrointestinal tract. Other symptoms such as nausea, vomiting.

SKIN CONTACT : Will cause irritation, redness and rash upon prolonged contact.

4. First Aid Measures

EYES: Immediately flush eyes with a directed stream of water for at least 15 minutes. Hold eyelids apart to ensure complete irrigation of all eye and lid tissues. Get medical attention immediately.
